On 01-17-14 at approximately 0153hrs, I Ofc Anderson, received a phone call via department cell regarding a possible sexual assault. The caller, identified as [REDACTED], that she had been sexually assaulted. Myself and Ofc Harris made contact with the victim at 1103 South Porter (Ornelas B) [REDACTED] stated that around 1500 to 1600 hrs on 01-16-14 her neighbor, identified as [REDACTED] in room [REDACTED], had come over with two males, only know as [REDACTED] and [REDACTED] to visit [REDACTED] also indicated that another friend, identified as [REDACTED], was also present in the room at this time. [REDACTED] stated that [REDACTED] left shortly after [REDACTED] and [REDACTED] arrived with [REDACTED] [REDACTED] went on to say that [REDACTED] and [REDACTED] left the room just shortly after the others. [REDACTED] stated that when [REDACTED] and her were alone, [REDACTED] began asking for oral sex, [REDACTED] told [REDACTED] no and [REDACTED] began taunting [REDACTED] and got closer to her. [REDACTED] stated that [REDACTED] pulled her shirt down exposing her breasts and that [REDACTED] then pulled his pants down exposing his genitals. At this point, [REDACTED] indicates that she told [REDACTED] no and the he pushed her on the bed, forcibly holding down her wrists causing pain and preventing his advance, and attempted to spread her legs. According to [REDACTED] knocked on the door and [REDACTED] moved out of her way so she could answer the door. At this point, [REDACTED] and [REDACTED] left the area. The victim is willing to make a written statement and press charges. This case is remains open for further investigation.

On 01-17-14 at 10:50 I interviewed [REDACTED] at the Police Annex. Her friend [REDACTED] was with her.

[REDACTED] advised on 01-16-14 between 1400 and 1600 she was in her room with [REDACTED], when there was a knock at the door. [REDACTED] opened the door and no one was in front of the door but coming down the hall from one direction was [REDACTED] her neighbor and coming down the hall from the other direction was two black males. One [REDACTED] recognized from around the hall but she didn't know the other. [REDACTED] stated the two males and [REDACTED] met at [REDACTED] door and started talking. [REDACTED] came out of the room and started playing around with [REDACTED]. [REDACTED] said she told everyone to come in instead of being in the hall. [REDACTED] stated at the time she thought [REDACTED] was friends both the males the way they talked.

[REDACTED] advised [REDACTED] and one of the males left the room to go to the lobby. The other male stayed in the room with [REDACTED]. [REDACTED] said she learned the male's name in [REDACTED] and he is a Texas College student. [REDACTED] stated she told [REDACTED] she was going to bed to sleep and got into her bed. [REDACTED] got onto the bed and pulled his penis out of his pants, grabbed her hand and tried to put it on his penis but she kept pulling away. [REDACTED] said he attempted this several times. After she refused [REDACTED] pulled her shirt up and licked her breasts.

[REDACTED] told [REDACTED] she wanted to go to sleep and he grabbed some of the blankets and laid next to her. She stated [REDACTED] knocked on the door and [REDACTED] opened the door for her. [REDACTED] stayed in bed. She got some chips and went back to the lobby. [REDACTED] later came by, knocked on the door telling [REDACTED] she was still around. [REDACTED] said it was not long after that that [REDACTED] and the other male who was in the lobby with [REDACTED] came to the room. [REDACTED] then left with the other male.

[REDACTED] concurred all the parts of being in the room and that she was in the lobby with the other male. She stated when she came into the room to get chips, [REDACTED] answered the door then got on the bed with [REDACTED].

[REDACTED] said during the rest of the afternoon and evening [REDACTED] would mention every once in a while that she couldn't believe he licked her breast. [REDACTED] said she finally asked what [REDACTED] was talking about. Campus Police was then contacted on 01-17-14 at 0155.

On 01-21-14 I contacted [REDACTED] with the assistance of Vice President of Student Affairs Dr. Campion at Texas College. An appointment was sent for [REDACTED] to come to Campus Police at 11:00.

After inquiring with [REDACTED] when and how many times he has been on campus he advised he was in Ornelas with his friend [REDACTED]. They went into a female's room who he didn't know but thought his friend knew them. [REDACTED] said when [REDACTED] and the other female left the room, [REDACTED] asked if he wanted to watch a movie with her. He stated he didn't have a problem with that. Shortly afterwards [REDACTED] told him to come sit on the bed because he would be more comfortable. [REDACTED] said he sat at the end of the bed with his back to the wall. It was inquired if any physical contact was made between the two. [REDACTED] denied any contact but stated [REDACTED] kept talking about how large her breasts are. He stated she stated to get uncomfortable and text [REDACTED] to come back to the room. [REDACTED] said [REDACTED] was not his type and he has a girlfriend in Bateman.

Cpl. Scott

██████ then showed me text messages he got from ██████. They state "This is ██████ what time does the kickback start? Are y'all still having kit?" He responded "At like 9 and yea". She says, "Okay. What apartment it's in or whatever? Ima let u know we get there". ██████ text, "Okay".

The text started at 20:46 on 01-26-14 and ended at 20:57.

██████ stated ██████ never did show but on the weekend he did see her at a party but only waved across the room at her.

I advised ██████ that he would be CTW from all TJC property and events because he is not a student. He would have to pick his girlfriend up on the street and not even go into the parking lot of Bateman.

██████ stated he understood.

██████ wrote a statement.

01-22-14 I met with ██████ at 10:35. I explained that I could not go any further with the case because of the text she sent ██████. ██████ said she sent it for her friend. I advised with her name and number on the text, it would be very hard to prosecute. ██████ understood.

This case is closed.
